Terms & Conditions

1. GENERAL

Perfect Place Interiors & Events (“PPIE”) and Perfect Place Weddings (“PPW”) provide home staging, wedding coordination, event staffing, and event styling services throughout Los Angeles and surrounding areas. All pricing provided is considered a starting estimate and may be adjusted based on property size, guest count, venue requirements, design scope, service complexity, premium furnishings or inventory needs, and location logistics. Final pricing is confirmed upon consultation and written proposal approval.

2. HOME STAGING TERMS

All home staging packages include an initial 30-day staging period unless otherwise stated in writing. Extended staging is billed in 30-day increments according to the selected package tier. Properties in premium markets including Beverly Hills, West Los Angeles, Hollywood, Santa Monica, and Malibu may require upgraded furnishings, expanded inventory allocation, enhanced design scope, or increased logistics. Pricing may increase beyond listed ranges. Clients are responsible for ensuring the property is clean, accessible, and photo-ready upon staging completion.

3. HOME STAGING NON-GUARANTEED DISCLAIMER

While home staging is designed to enhance presentation, improve buyer perception, and increase market appeal, Perfect Place Interiors & Events does not guarantee the sale of a property, a specific sale price, the speed or timing of a sale, multiple offers, or market performance outcomes. Real estate market conditions, pricing strategy, property condition, location, interest rates, buyer demand, agent performance, and other external factors may significantly affect the sale of a property. Staging is intended as a marketing and presentation enhancement service only.

4. WEDDING & EVENT TERMS

Wedding packages are designed for events ranging from 10–60 guests. Packages may include officiant, photographer, videographer, DJ, bartender, staffing, cake and champagne service, floral coordination, and dinner coordination. Venue fees are not guaranteed to be included unless expressly stated in writing. Dinner and catering services are priced according to guest count, catering style, service level, and vendor pricing.

5. EVENT STAFFING TERMS

Staffing services may include tray passing, food service, buffet monitoring, setup, breakdown, cleanup, plate clearing, and guest assistance. A 4-hour minimum per staff member may apply. Travel time and transportation fees may be included in the quote or billed separately depending on event location and logistics.

6. DEPOSITS & PAYMENTS

A non-refundable retainer or deposit may be required to secure event dates, staging inventory, staffing reservations, and vendor coordination. Final balances are due according to the payment schedule outlined in the client agreement.

7. CANCELLATION & RESCHEDULING

Deposits and retainers are generally non-refundable due to reserved inventory, scheduling commitments, vendor coordination, and staffing allocation. Rescheduling requests are subject to availability.

8. THIRD-PARTY VENDORS

PPIE/PPW may coordinate third-party vendors including caterers, photographers, DJs, florists, and rental companies. Vendor pricing, availability, and performance are subject to third-party agreements and conditions.

9. LIABILITY

PPIE/PPW shall not be held liable for venue restrictions, weather conditions, vendor cancellations, guest misconduct, damage caused by clients or guests, or delays outside reasonable control.

10. FINAL PRICING & ACCEPTANCE

Final pricing is determined by property size, venue selection, guest count, design scope, staffing requirements, vendor selections, luxury inventory requirements, and event duration. Submission of payment, signed agreement, or booking confirmation constitutes acceptance of these Terms & Conditions.
