- 4. Food Vendor will be provided an 8' x 12' Booth and space. Food Vendor must bring their own tables, chairs or equipment. Electricity is VERY LIMITED ONE 110V plug for one light. <u>Set up is for propane cooking only.</u>
- 5. There are specific loading areas <u>surrounding the event</u>. <u>No loading or unloading allowed during the event hours</u> <u>of 11 a.m. to 10:00 p.m.</u>
- 6. Only ONE vehicle allowed inside event area for parking. Official Parking Pass will be issued prior to event.
