I intend this to be a complete and unconditional release of all liability to the greatest extent allowed by law which includes employees, officers and contract employees of the Morning Line Farm and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect. I further agree to indemnify, defend and hold the Morning Line Farm, and their officers, directors, employees, and agents, harmless from any liability relating to personal injury or injury to real or personal property of any kind arising out of the ordinary negligence, willful or wanton negligence, or intentional acts of the undersigned. This Release is governed by the law of the State of North Carolina.
