BLUE RIDGE TROUT FESTIVAL & OUTDOOR ADVENTURES is a trout fishing and outdoor adventures festival, presented from 10 am to 6 pm on April 25, 2026, on the downtown city park grounds of Blue Ridge, GA, in Fannin County. All exhibitors and non-profits must be approved by the Blue Ridge Trout & Outdoor Adventures Festival Committee (BRTF EVENT COMMITTEE), which reserves the right to permit exhibitors and limit activities of exhibitors at its sole discretion. Only exhibitors, organizations and products that are approved by the BRTF EVENT COMMITTEE will be permitted on site at the event.

The *Official Trout Festival of Georgia* returns to downtown city park in Blue Ridge, Georgia, gathering fishermen, river sports enthusiasts, and outdoor recreation fans and their families in Blue Ridge, Georgia for fun, food, activities, entertainment, shopping and recreational services, while increasing the public's knowledge of trout and the cold-water conservation associated with Trout Unlimited.

The all-volunteer, fundraising event combines trout fishing and fly-fishing with services that engage mountain biking, hiking, camping, kayaking, paddling and boating ... retail vendors present wildlife-oriented art/housewares/decor, outdoor recreation gear, outfitters/guide

services/information, foods, ... and the return of the [TROUT FEST ACTIVITY ZONE](#) and staged concerts at the [TROUT FEST SOUND STAGE](#) top the day in the historic, downtown district of Blue Ridge. Net proceeds of Trout Fest support cold-water conservation, education, recreation and community outreach programs funded (all or in part) by Blue Ridge Mountain Trout Unlimited #696.

NOTE: All exhibitors are required to assign to the event host a Certificate of Insurance proof of liability insurance upon approval of the Exhibitor Application. See "INSURANCE REQUIREMENTS" for more information.

BRTF provides exhibitors with the following:

- Exhibitor Hospitality Booth on Saturday (8:30 am to 5pm) providing bottled water, volunteer services
- Friday load-in: 3 pm to 9 pm.
- Saturday load-in: 7 am to 9 am.
- On-site security (day of Trout Fest)
- City vendor permits (\$60.00) included in booth fee
- Access/exposure of company logo and/or service photos/messages on event's social-media channels including event website, Facebook, Instagram

TROUT FEST 2026 EXHIBITOR RULES AND REGULATIONS

TROUT FEST 2026 is themed as a trout fishing and outdoor adventures festival – outdoor recreation oriented – staged on city park grounds in downtown Blue Ridge, GA (Fannin County).

TROUT FEST '26 takes place 10 am to 6 pm on April 25, 2026 – application deadline is March 31, 2026

All exhibitors and non-profits must be approved by the Blue Ridge Trout Festival & Outdoor Adventures Committee (BRTF EVENT COMMITTEE), which reserves the right to permit exhibitors and limit activities of exhibitors at its sole discretion. Only exhibitors, organizations and products that are approved by the BRTF EVENT COMMITTEE will be permitted.

Insurance Requirements – All exhibitors are required to assign to the event host a Certificate of Insurance proof of liability insurance upon approval of the Exhibitor Application. Insurance minimums: Each Occurrence — \$1M/Personal & ADV Injury — \$1M/General Aggregate — \$2M/Products — \$2M/Comp, Opp agg. Exhibitors classified as “Hazardous” or with additional risk (visitor-engaged activities) shall name the event host as “Additional Insured.”

Booth location will be assigned by BRTF EVENT COMMITTEE. Some exhibitors may be grouped together so they are closer to utilities compatible with their needs. Multiple spaces may be requested for an additional \$225 per space. Exhibitor tents are not provided. Electricity is available upon request (fee applied) and will be run throughout the festival for hook up. Exhibitors should provide their own heavy-duty extension cords and power strips. Water hookups (fee applied) are available, but exhibitors must supply their own hoses. **You must complete your electricity and water requirements on the application to receive these services.**

One Exhibitor per booth space; sharing of booth space is not allowed. Exhibitors cannot sublet or apportion space to anyone else. Set-up is allowed during allotted times only. While the BRTF EVENT COMMITTEE will make every effort to accommodate specific booth-site requests (see application), we cannot guarantee booth locations, and locations will be assigned by BRTF EVENT COMMITTEE. Booths must be set-up within their designated 10' x 15' space. If your booth is located in the park, the ground may not be level, so come prepared. If your booth is located on the street surface, bring necessary equipment for street set-up. Exhibitors must provide their own tents, displays, chairs, tables, set-up equipment, change, etc. **Tent weights/anchors are required for all set-ups.**

BRTF EVENT COMMITTEE reserves the right to ask any exhibitor to remove any work or exhibit deemed not acceptable by the BRTF EVENT COMMITTEE at the sole discretion of the BRTF EVENT COMMITTEE. The BRTF EVENT COMMITTEE reserves the right to remove from our mailing list and social-media channels any exhibitors who display unprofessional behavior.

Exhibitors must exhibit from 10 am to 4:30 pm but may exhibit for the duration of the festival (until 6 pm). **There is no rain make-up date – come prepared for rain or shine.** Booth must always be open and manned during festival hours. Exhibitors are responsible for booth set-up, break-down and security of your property.

Booth must be set-up and ready for business by 9:30 am on event day. All vehicles, trailers and debris are to be off the adjacent streets and cleared from the festival area by 9:30 am. After unloading and setup, vendor vehicles and trailers must be moved to designated exhibitor parking area(s). Vehicles and trailers are not permitted to enter the festival grounds and area during festival hours of operation, unless otherwise approved by the BRTF EVENT COMMITTEE. **Exhibitors will not be allowed to park cars, trucks, or trailers at the curb surrounding the park during festival hours – NO EXCEPTIONS.** Exhibitors must unload and move vehicles immediately to designated parking areas. If exhibitor carries additional stock, it is suggested to bring a dolly or handcart to bring additional stock to booth as necessary. Exhibitors are responsible for cleaning up booth space upon closing of the festival.

Exhibitors are responsible for Georgia State Sales Tax collection in Fannin County and reporting (7%) and any other sales fees or other charges that may be applicable to any activity relating to this festival.

Music and amplified sound are restricted to pre-approved Entertainment Exhibitors only. Also, while the event is “pet friendly,” exhibitors must ensure all pets are quiet and do not disturb either attendees or other exhibitors.

Food Vendor Booth space provides for electricity and water for a fee (see application). Exhibitors must provide their own heavy-duty extension cords and power strips, food-grade water hoses, ice and other supplies and materials needed to operate their booth, change, etc. Grease/oil must be securely contained and removed from the premises at the end of Festival. Food Exhibitors are required to use the provided dumpsters for booth trash. Food Exhibitors cannot leave debris, boxes, etc. at booth space. Food Exhibitors are required to bring a 55-gallon trash can to put next to their booth for use by the public (these will be emptied by park clean-up staff). Food Exhibitors are responsible for complying with all state of Georgia health and safety regulations.

The sale of food items is restricted to pre-approved Food Exhibitors only. Sales of alcoholic beverages are prohibited without prior arrangement/approval with BRTF Event Committee.

Author’s Table is a shared presentation of approved authors’ works. The city sales permit is paid for by BRTF and applies to all table sales. Trout Fest ‘26 provides a tented site, display tables and two chairs per author. Table presentations shall be accompanied from 10 am to 4:30 pm by the author or his/her representative. Sales shall be processed by the author or his/her representative.

Cancellations for Trout Fest ‘26 will be accepted until April 4, 2026. Cancellations will be given a 50% refund of the paid vendor fee, provided the cancellation request is made in writing via email to Blue Ridge Trout & Outdoor Adventures Festival at info@gmail.com; or by letter to the Blue Ridge Trout & Outdoor Adventures Festival, PO Box 2745, Blue Ridge, GA 30513. **Trout Fest ‘26 cancellations on or after April 5, 2026, and no-shows will not receive a refund of any fees submitted through the application process.**

BRTF EVENT COMMITTEE reserves the right to remove any exhibitor from the event who does not adhere to all EXHIBITOR RULES AND REGULATIONS set forth by the BRTF EVENT COMMITTEE. Non-compliance with the rules and regulations set forth may affect obtaining booth space in future associated events.
