2. Information We Collect

We may collect the following types of information:

We do **not** collect Social Security numbers, financial account details, or any other highly sensitive personal identifiers unless clearly stated and required for a specific purpose (e.g., incentive disbursement).

3. How We Use Your Information

The information we collect is used strictly for research and analytical purposes, including:

- Conducting public opinion research
- Improving the quality and relevance of our services
- Analyzing data trends and generating reports
- Contacting participants (if applicable and consented)

We do not sell or rent your personal information to any third parties.

4. Sharing and Disclosure

We may share aggregated and anonymized data (which cannot be used to identify you) with:

- Research partners and clients
- Academic institutions
- Advocacy organizations
- Public agencies or media, for educational or public reporting purposes

We may also disclose your personal information if required by law, subpoena, or court order.

5. Data Security

We take data protection seriously and implement appropriate physical, technical, and administrative safeguards to protect the personal information we collect. Access to identifiable data is restricted to authorized personnel only.

6. Your Choices and Rights

- **Participation is Voluntary:** You may refuse to answer any question or withdraw from a survey at any time.
 - **Access and Corrections:** If we collect identifiable data, you may request access or corrections to your information by contacting us.
