## 1. Information We Collect

- With your explicit consent, send promotional or marketing communications.


## 3. Email Correspondence

## 4. Text Messaging (SMS) Policy

If you provide your phone number and "Opt-In" to receive text messages, the following applies:

- **Frequency:** Message frequency varies based on your interaction with us.
- **Consent:** By checking the consent box on our form, you authorize Seren Realty Co. to send text messages (which may include automated marketing messages) to the mobile number provided. Consent is not a condition of purchase.



- **Opt-Out:** You can cancel the SMS service at any time. Just text "**STOP**" to 401-352-5580. After you send the SMS message "STOP" to us, we will send you an SMS message to confirm that you have been unsubscribed.
- **Help:** If you are experiencing issues with the messaging program, you can reply with the keyword **HELP** for more assistance.
- **Carrier Fees:** Message and data rates may apply for any messages sent to you from us and to us from you.

We do **not** sell, rent, or lease our contact lists to third parties.


