# KDP is now recruiting

for an upcoming cohort of Navigators starting Fall 2025.

#### Overview

KDP developed the Registered Apprenticeship (RA) Navigator program for workforce intermediaries to help expand apprenticeship throughout the Commonwealth.

The RA Navigator is an apprenticeship program that trains people to start and manage apprenticeship programs.

RA Navigators help grow the apprenticeship ecosystem through regional partnerships and provide technical assistance to unions, employers, industry associations, community organizations, training providers, and the workforce system. The one-year apprenticeship program includes 2,000 hours of on-the-job training (OJT) plus 144 hours of Related Technical Instruction (RTI). The program also uses online collaboration platforms to support the RTI, facilitate discussions, and provide additional resources.

#### **Current Status**

As of Spring 2025, five cohorts of Navigators have completed their training and a sixth cohort is in progress. While the majority of the more than 120 Navigators supported to date have been state workforce staff, the first six cohorts have also included representatives of community colleges, unions, the PA Office of Vocational Rehabilitation (OVR), and other workforce intermediaries.

## Keystone Apprenticeship Alliance (KAA)

Graduates of the Navigator program have become members of the *Keystone Apprenticeship Alliance*, the programmatic capstone and central long-term outcome of the RA Navigator Program. The KAA is envisioned as a network of intermediaries able to assist unions and employers to expand apprenticeship programs into new occupations and industries. It will meet regularly to collaborate on current apprenticeship development projects, share resources and best practices, and network internally to meet the needs of employers and other apprenticeship partners as they stand up new programs. As more Navigator cohorts are completed, more members will join the KAA. Each will bring their own salient perspective on apprenticeship opportunities within their own local networks. By continuing to guide and oversee the activities of the KAA, KDP will maintain an active role in coordinating the expansion of apprenticeship throughout the state.

### **Upcoming Cohorts**

KDP is now recruiting for new statewide Navigator cohorts. RTI will be delivered online via Zoom and other collaboration platforms. Candidates include those who currently serve or aspire to serve as apprenticeship coordinators, business services representatives, job developers, education coordinators, non-profit and community-based organization leaders, and union representatives.

All applicants must be employed fulltime by an employer who will help facilitate the apprentice's OJT. Sponsors will receive a **Job Book** to help them accurately monitor and track the job skills their apprentice will learn through on-the-job training. They will also receive **Mentorship Training** in advance of the cohort starting, and receive ongoing guidance to help them successfully manage their apprenticeship program.
