

MNCoyoteHunt.com LIABILITY WAIVER AND RELEASE AGREEMENT

1. Acknowledgment of Risk I, the undersigned participant, acknowledge that participation in the MNCoyoteHunt.com hunting contest involves **inherent risks**, including but not limited to:

- The use and discharge of firearms or other hunting equipment.
- Harsh weather, rough terrain, and natural hazards (such as ice, water, trees, and wildlife);
- Vehicle travel on public or private lands.
- **The risk of injury, death, or property damage caused by me, to me or others.**

I understand these risks and **voluntarily choose to participate** in the contest fully aware of the potential dangers.

2. Assumption of Responsibility I **assume full responsibility** for any injury, death, or property damage that may result from my participation in the event, whether caused by negligence or otherwise, and agree that I am solely responsible for my actions before, during, and after the contest.

3. Release of Liability In consideration of being allowed to participate in MNCoyoteHunt.com, I hereby **release, waive, discharge, and covenant not to sue** the event organizer(s), landowners, sponsors, co-sponsors, affiliated companies, donors, volunteers, event staff, officers, agents, employees, or any other persons or entities associated with the event (collectively, the “Released Parties”) from **any and all liability, claims, demands, actions, or causes of action** arising out of or related to any loss, damage, injury, or death that may occur as a result of my participation in the contest or my use of private or public land.

This release applies to **any and all claims**, including those caused by the **negligence of the Released Parties**.

4. Compliance with Laws and Safety Rules I agree to:

- Comply with all **federal, state, and local hunting laws and regulations**, including but not limited to those set forth by the **Minnesota Department of Natural Resources (DNR)**;
- Certify that I **fully understand the Minnesota hunting laws and regulations** applicable to this event, including firearm safety, seasons, licensing, and tagging requirements.
- Follow all **firearm safety practices** and contest-specific safety rules.
- Refrain from using alcohol or illegal substances before or during the hunt.

- Respect all **landowners' property, livestock, and boundaries.**

I understand that any violation of Minnesota law or event rules may result in immediate disqualification, forfeiture of entry fees, and potential legal action.

5. Medical Treatment and Insurance I certify that I am in good physical health and have **sufficient medical insurance** to cover any injury I may sustain. I authorize medical treatment deemed necessary in the event of an emergency and agree that the Released Parties are not responsible for any costs associated with such treatment.

6. Use of Name and Likeness I grant permission for the use of my **name, image, and likeness** in photographs, videos, or promotional materials related to MnCoyoteHunt.com and its sponsors, without compensation.

7. Hold Harmless and Indemnification I agree to **indemnify, defend, and hold harmless** the Released Parties from and against all **claims, damages, losses, liabilities, costs, and expenses (including attorney's fees)** that may arise out of or be related to my participation in the event, including but not limited to:

- Any injury or damage caused by my own actions or omissions.
- Any violation of Minnesota laws, event rules, or safety regulations.
- Any claims brought by third parties because of my conduct.

I understand that this means I will be responsible for any costs incurred by the Released Parties if a claim is made against them because of my participation.

8. Binding Effect This release is **binding on myself, my heirs, executors, administrators, and assigns.** I have read and fully understand this waiver and sign it voluntarily, intending to be legally bound.
