Be it remembered that the Mayor and Board of Aldermen met in a Regular Meeting Wednesday July 2nd, 2025, at 6:00 p.m. in the Corporation office of Snow Lake Shores. There being present, Mayor Harry Leuer, Alderman Mike Fly, Alderwoman Stephanie Butler, Alderman Shawn DeCrow Alderwoman Cynthia Brinkmeyer and Alderwoman Brenda Bartus. Attending the Mayor and board were the attorney Chris Childers and Town Clerk Sheri Briggs.

OLD BUSINESS:

1. APPROVE THE MINUTES OF THE JUNE 4TH 2025 REGULAR MEETING

There came consideration the matter of approving the minutes of the June 4th 2025 regular meeting. Upon the motion of Alderwoman Butler, duly seconded by Alderwoman Bartus, all in favor and the motion carried.

2. APPROVE THE BILLS TO BE PAID FOR JULY 2025

There came consideration the matter of approving the bills to be paid for July 2025. Upon the motion of Alderman DeCrow, duly seconded by Alderman Fly, all in favor and the motion carried.

NEW BUSINESS

1. APPROVE TO APPOINT SHERI BRIGGS AS TOWN CLERK

There came consideration the matter of approving a mayor pro tempore. Upon the motion of Alderman DeCrow, duly seconded by Alderwoman Brinkmeyer. Alderman Fly and Alderwoman Butler voted NO. That being a tie Mayor Leuer voted YES and broke the tie. The majority in favor and the motion carried.

8. APPROVE MAYORS PAY PER MONTH

There came consideration the matter of approving the mayors pay per month. Upon the motion of Alderwoman Butler, duly seconded by Alderman Fly, all in favor and the motion carried.

9. APPROVE ADDING MAYOR LEUER AND VICE MAYOR BARTUS TO CHECKING ACCOUNTS AND TAKE OFF DOUG IRBY.

There came consideration the matter of approving adding Mayor Leuer and vice mayor Bartus to all checking accounts and removing the previous mayor, Doug Irby. Upon the motion of Alderwoman Butler, duly seconded by Alderman DeCrow, all in favor and the motion carried.

10. APPROVE THE MAYOR AND BOARD GOING TO MML CONFERENCE IN BILOXI

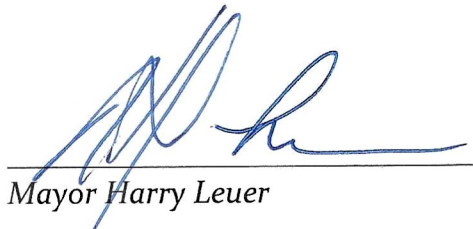
