Alderwoman Butler made the motion to adjourn executive session, duly seconded by Alderman DeCrow, all in favor and the motion carried.

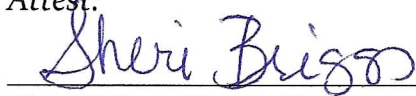

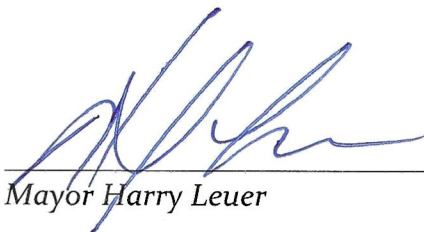
NEW BUSINESS

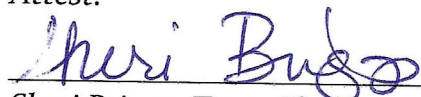
