## Booth Policies, Procedures and Requirements

### APPLICATION REJECTIONS AND CANCELLATIONS POLICY:

Gold Show reserves the right to reject any and/or all applicants. In the event of cancellations or no-shows, assignment of available space(s) will be left to the discretion of the Gold Show Committee.

**BOOTHS:** Inside Booth spaces are 10' wide x 10' deep. Vendors are responsible for providing their own signage. Each booth will be given one 8' table, Corner booth get 2 tables. **Additional chairs and tables can be rented upon request at vendors expense.**

**ELECTRICITY:** There is limited electrical power available at the Gold Show. We can supply you only **15 AMPs at 120 Volts or a total of 1800 Watts**. At a cost of \$30.00. The power source will be within 100 feet of your booth. You must supply YOUR OWN 100 foot - UL Approved Cord - must be three (3) wire #12 - "U" Ground type. **Power only available if pre-registered.**

**GENERAL RULES:** Approved Vendors will receive an information packet with additional rules and regulations. Vendor must read these rules and adhere to them.

**INSURANCE REQUIREMENTS:** All FOOD vendors will be required to provide a certificate of insurance in the amount of \$1 Million naming the Delta Gold Diggers as additionally insured. The policy will be a general liability coverage policy.

**LIABILITY & SECURITY:** The Gold Show, Delta Gold Diggers Board of Directors and volunteers will not be responsible for losses of any kind. Whether by fire, theft, physical violence, elements of nature, or any other cause, however the origination. The Gold Show will provide security for the course of the event however, participants are responsible for their own merchandise and equipment, its protection and insurance.
