Services

1. This Contract is for the services provided by BB Videography & Photography.

Terms of Agreement

Payment

2. Payment is confirmed once a deposit is paid.
3. The remaining balance is due no usually the day prior to the session. For seasonal minis dates will vary.
4. If there is any add on services or products are requested after the event date, you will need to pay the agreed amount for the add on before gallery or USB is sent.

Termination

5. If for any reason you need to terminate this contract all moneys paid at the time will be forfeited.
6. If BB Videography & Photography is for whatever reason unable to attend on the day the following options will be.
 - A) A full refund will be paid back into the card you booked with
 - B) Reschedule and offer new dates for services

Travel & Accommodation

7. For work outside of Sydney, travel fees are calculated at \$2 per km from Sydney city centre. Fees are discussed prior and added to the remaining balance.

Product Ownership

8. BB Videography & Photography has the rights to use any material from the event for business purposes.
9. Any third party business that work for or with BB Videography to the event also have full rights to use any material from the event for business purposes.

Protection and Privacy

- 9.1 BB will always request permission before posting any images or content from your session.
- 9.2 As a part of our child protection protocols, no personal details are shared online; including and not limited to first or last names, area of residence, schools, workplaces, regular places of familiarity or any identifying details.

Limitation of liability

10. In no event will BB Videography & Photography be liable for any amount exceeding the price paid by the client for the Services giving rise to the claim.
11. If you are for whatever reason unhappy with the work provided you are not entitled to any refund. It is assumed that you have seen and are content with the quality of work provided by BB Videography & Photography prior to booking.

13. Should there be any technical fault that causes a loss of all footage captured, BB Videography & Photography will offer either

- A)** A total refund of moneys paid, no further service required.
- B)** BB Videography & Photography will engage in data recovery services to attempt to recover lost data. If footage can be recovered BB Videography & Photography will complete the service and will require a payment 50% of the value of Data recovery services rendered prior to sending the USB with the completed products. If data recovery service is not successful BB Videography & Photography will process a refund of the amount paid by the client minus the fee for data recovery services.

Governing Law

14. The terms of this Agreement shall be governed and construed in accordance with New South Wales Law.

Damages

15. If any equipment owned by BB Videography & Photography is damaged by any person at client event, then client is liable for a \$500 fee for damages and repair.

Quality by secondary services

16. BB Videography & Photography is not responsible for any quality issues with secondary services; printing companies or album/photo book providers.

RAW Footage

17. (Only applies to Videography work) Raw footage is an add on to packages provided by BB Videography & Photography and not an included product. BB Videography & Photography shooting style means videos vary in length, full length footage is not standard practice. If you want full length footage of any part of the day you must give written detail by email of what parts of the day you want in full.

18. There is an option to purchase RAW images from your photography session when you get your gallery. Please note these are untouched RAW images. Not all images in the RAWs will be usable by means of focus, lighting, colour and position.

By proceeding with your booking with a paid deposit, you are accepting the terms of this contract without prejudice.
