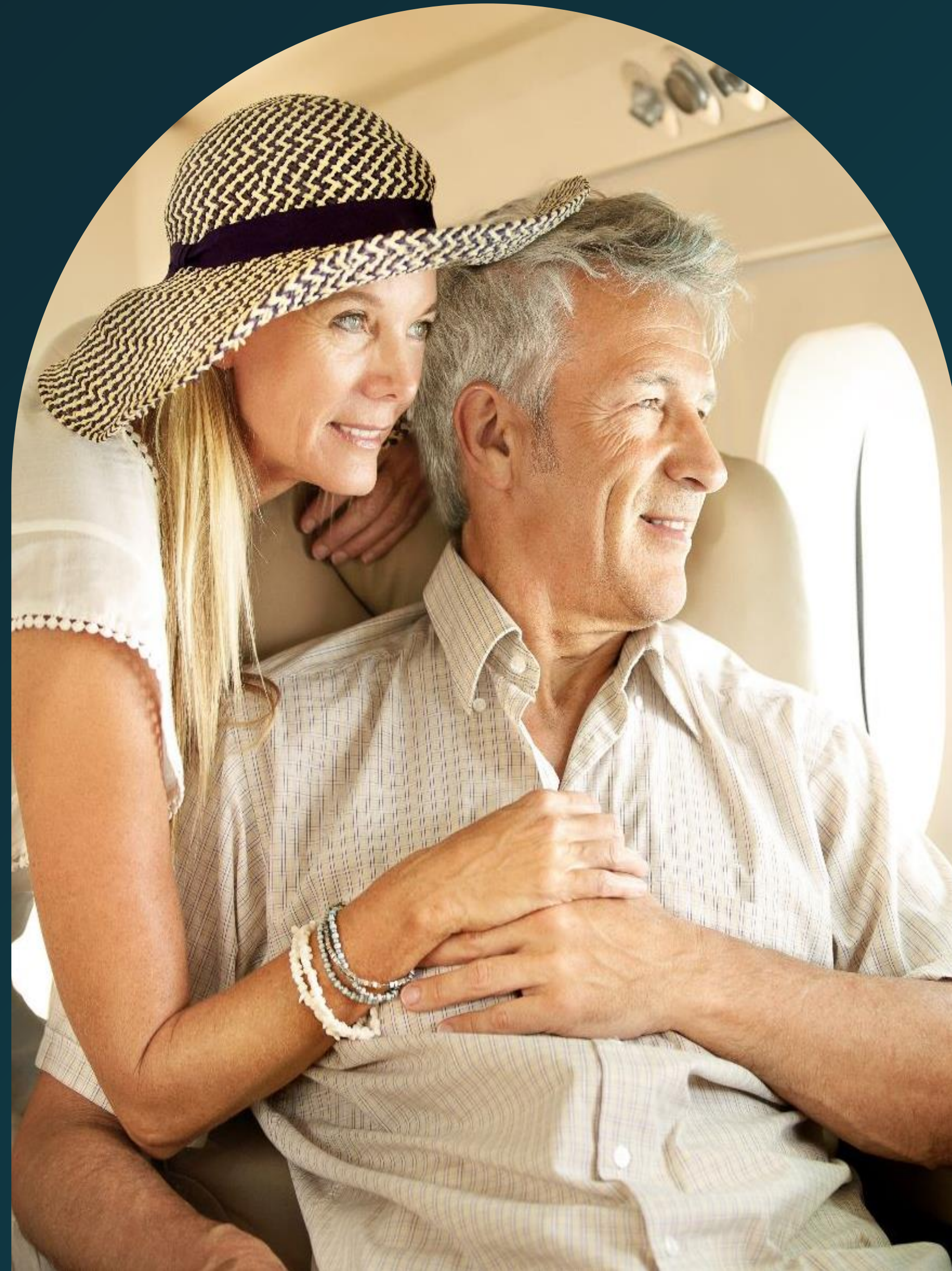

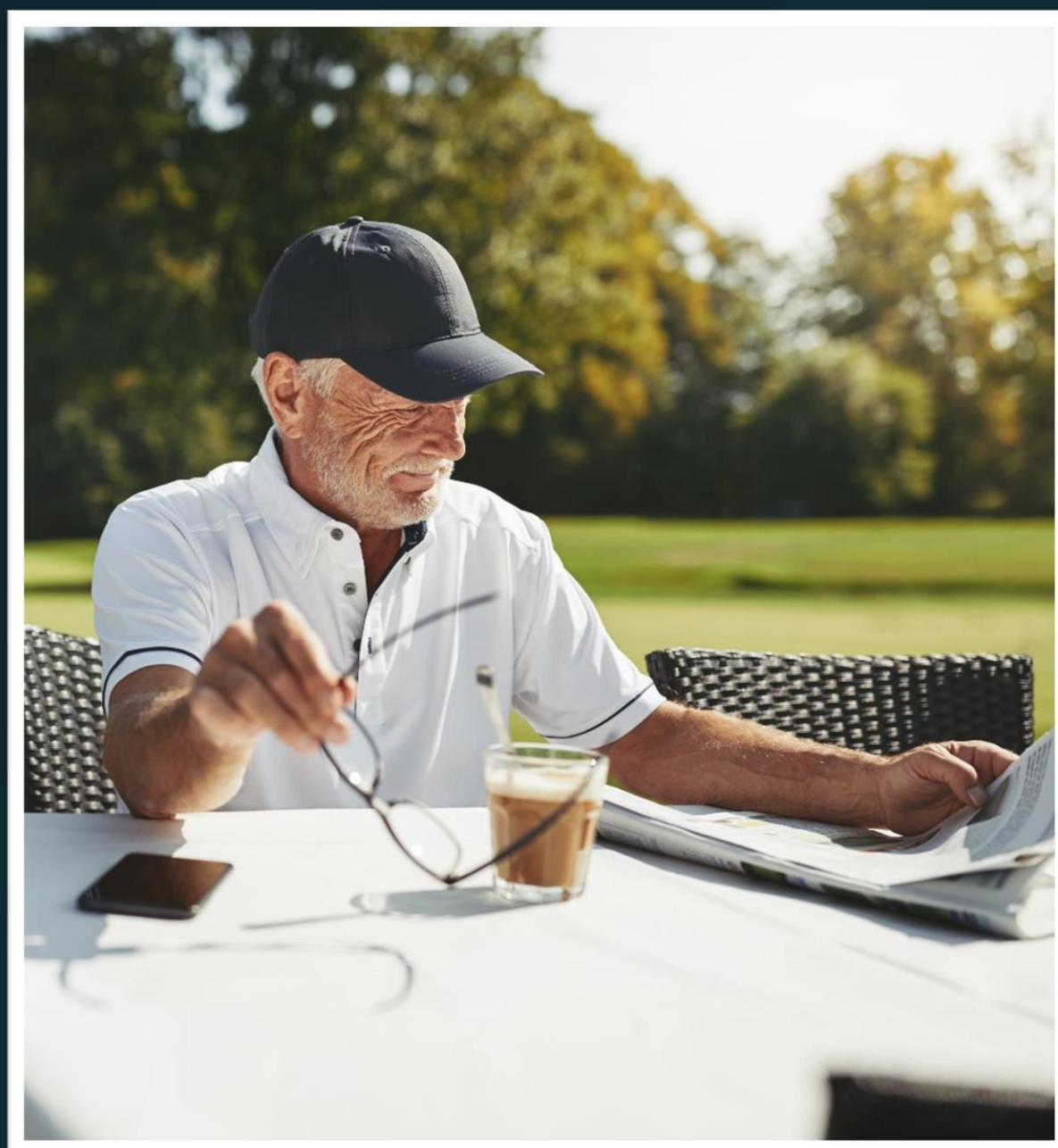

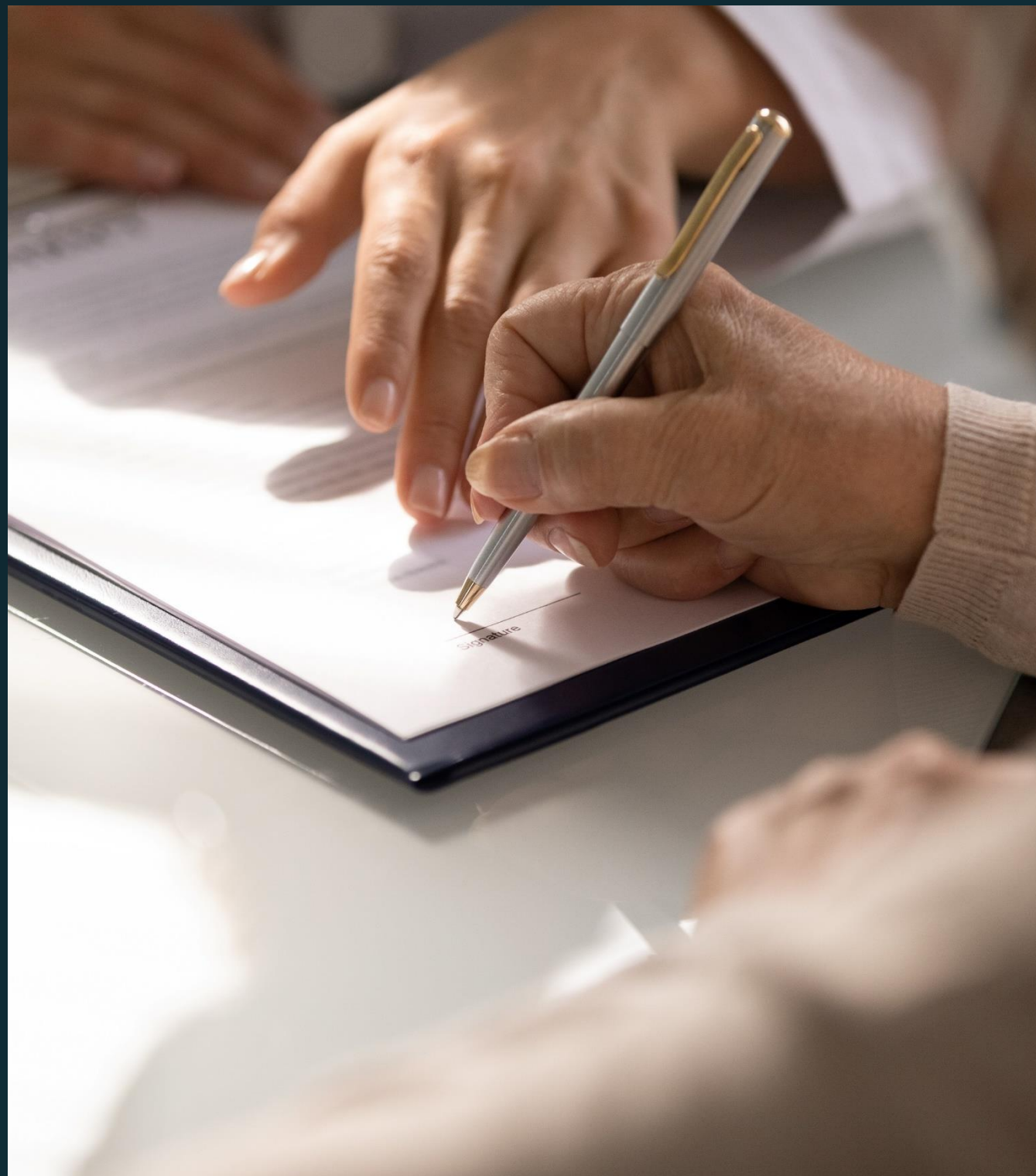
❖ Certificate of activity issued by the church or congregation, provided that it is recognized by the Portuguese legal system.

LEGAL PACKAGE

The D7 VISA Visa process begins with granting Power of Attorney to lawyers, followed by obtaining a Tax Identification Number (NIF) and designating a Fiscal Representative. Lastly, opening a Portuguese bank account is required for the program

VFS / CONSULATE

The Lawyer will provide comprehensive assistance for D7 Visa applicants before VFS/ Consulate, ensuring to the D7 Visa applicant that all necessary documents are accurately and timely prepared and submitted and obtain a residence visa.

PROCESS

After the Visa stamp in their passports, applicants must gather all the necessary civil documents. Lawyers will guide them perform the correspondent due diligence for the submission before ALMA. An appointment at ALMA will be arranged for to attend in person.

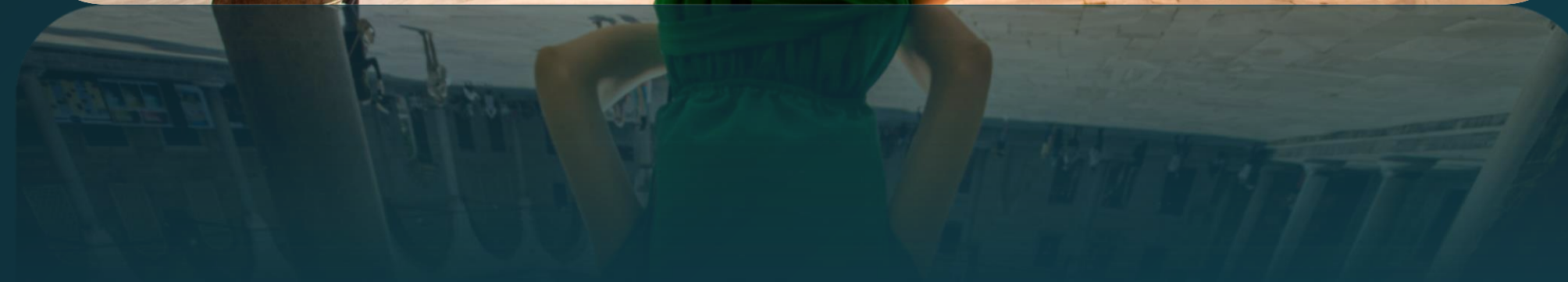
