




The program allows the applicants to live, work and study in Portugal, being mandatory to spend at least 7 days per year in Portuguese territory.

Capital transfer equal or superior to 500,000 euros for the incorporation of a commercial company with headquarters in Portugal, of at least five jobs, for a minimum period of three years.



### INCORPORATION OF A COMMERCIAL COMPANY WITH HEADQUARTERS IN PORTUGAL, COMBINED WITH THE CREATION OF 5 PERMANENT JOBS

To apply for Portugal's Golden Visa, non-EU nationals need to make a qualifying investment in Portugal, either personally or through a company.

Alternatively, the transfer can be used to increase the share capital of an existing company with headquarters in Portugal, with the maintenance of at least ten jobs, of for a minimum period of three years.


For investment through the creation of at least 10 jobs, this requirement can be reduced by 20 per cent (8 jobs) when it is made in low-density territory (NUT III level with less than 100 inhabitants per km2 or GDP per capita of less than 75 per cent of the national average).



#### THE LEGAL PACKAGE



The Golden Visa process begins with granting Power of Attorney to lawyers, followed by obtaining a Tax Identification Number (NIF) and designating a Fiscal Representative.

Lastly, opening a Portuguese bank account is required for the program

#### THE INVESTMENT



Applicants must transfer funds to their Portuguese bank account to make the eligible investment . Lawyers will assist the client to perform the investment on the client's behalf. All original documents will be delivered in person to the client.

#### THE PROCESS



the After completing investment, the clients become eligible for the Golden Visa Progam. Lawyers will guide them with the document preparation and due diligence for the submission before AIMA. That will then review and decide.

### THE PROCESS

The process of obtaining the Residence Permit takes place in the Immigration Office (SEF) and is comprised of three phases:

- 1. The Petitioning Phase: Online Submission + Pre-Approval (between 2 4 months)
- 2. <u>The Granting Phase</u>: Appointment + Approval (between 6 8 months)
- **Residency Card issuance** (2 to 4 weeks) 3.

\* Due to Covid and recent law changes, AIMA takes longer to conclude the processes. The timeline is merely indicative.


