



2026 PSBO ONLINE SALE RULES & REGULATIONS

Sale Date: June 27th, 2026 (9am – 6pm on DLMS)

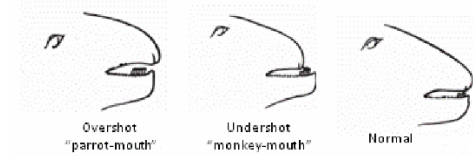
- A.** Consigners of purebred sheep at the PSBO Sale must be members for 2026 at the cost of \$25.00.
- B.** Entries close: May 31st, 2026. A required fee of \$20.00 per entry. Entry fees must accompany entries. Selling commission is 12% for all sheep plus the cost of transfer fees.
- C.** All purebred animals must be registered, legibly tattooed or tagged to meet the regulations of the Canadian Livestock Records. Animals must also be accompanied by the proper pedigree from CLRC, properly signed for transfer OR digital proof of registration can be used, should a printed certificate be unavailable.
- D.** All animals may be subject to inspection for health and soundness by the PSBO Sale sub-committee. It is recommended that all consigners familiarize themselves with the Code of Practice. REQUIREMENTS: SEE SECTION K
- E.** There is no sale quota per farm unit. Separate entry forms for each animal are required via Google Forms. All entries must be born, the property of the consigner. Ages of acceptable entries are Yearlings and Lambs of both sexes. The Sale sub-committee reserves the right to limit entries.
- F.** All animals are to be washed and neatly presented. All other animals should be in short fleece except for long wool breeds, which may be sold in full fleece. The Sale sub-committee recommends that short fleece be 1" or less. No artificial coloring or tampering of sheep will be tolerated.
- G.** All animals must be tagged to meet the current CFIA regulations.
- H.** Failure to comply with the above rules will result in disqualification from the sale.
- I.** Bids will start at \$500 for purebred sheep, if they do not sell for that, they will be noted as a NO SALE with no commission being charged to the Consigner. Cosigners may choose to set a personal reserve amount, above \$500, whereby in the case "bidding in" an animal, they will also be noted as a NO SALE, however, commission will be charged to the consigner for the "bid in" amount.
- J. REMINDER:** Sheep entry and photo entry deadline is **Sunday, May 31st, 2026**, which will be strictly enforced. SEE SECTION P (photos).

Payment Method: Cheque (Purebred Sheep Breeders of Ontario) or e-transfer (psbo.secretary@gmail.com) are acceptable payments

K. As this is an online sale we strongly urge consignors to check to ensure the soundness of the animals you wish to consign.

2. Eyes
3. Boils/open scabs
4. Poor Mouths

6. General health concerns

All of the above are cullable offences. We, the PSBO, take pride in running a great sale with sound dependable sheep for our buyers who trust our genetics.



L. By entering the PSBO Online auction you are agreeing to our buyers guarantee that all animals are sound, healthy and will breed if handled properly. Any disputes are to be handled in a professional manner between seller and purchaser.

M. IT IS STRONGLY ENCOURAGED FOR THE STRENGTH OF THE SALE THAT ANIMALS ENTERED BE ON DISPLAY AT Rockton Fairgrounds Saturday June 27th, by 8am.

N. Animals planning for early arrival, on the evening of Friday June 27th, must arrange a time with the Sale sub-committee PRIOR TO ARRIVAL on site, and cannot arrive after 9pm.

O. Purchased animals must remain onsite until the complete closure of the sale on DLMS, and cannot be loaded until proof of purchase is provided to a designated member of the Sale sub-committee.

P. All entry forms are to be completed through a Google Form and photos of the animal are to be emailed to Travis Dow at travdow4@gmail.com. When submitting your photos please name the files by the sheep's tag number so we can easily sort through the photos. (Example of the 3 Photo format we request)
