**Governing Law:**

- A. All questions concerning the construction, validity, and interpretation of this MOU will be governed by the laws of India. The Courts of Chennai, Tamil Nadu shall have exclusive jurisdiction for all matters arising out of or in connection with this MOU subject to the clause below.
- B. The Parties shall amicably resolve any and all disputes under this or arising out of or in connection with this MOU within 30 (thirty) days from the date on which the dispute has been raised by either Party, failing which the dispute shall be settled in accordance with the provisions of the Arbitration and Conciliation Act, 1996. The Parties shall mutually appoint a sole arbitrator to conduct the arbitration proceedings. The venue for arbitration shall be Chennai and the language for arbitration shall be English.
