### TERM DEFINITION:

### DATE AND TERM:

### DELIVERABLES OF URJOTSAV'24 RGIPT:

1. Logo placement of LWT on website, posts and carousels.
2. Promotion and publicity through our official social media channels.
3. Sharing dataset of all the winners eligible for LWT scholarship (up to 50 students).

### AMENDMENTS AND ARBITRATION:

- This Memorandum of Understanding is only applicable for events staged as part of URJOTSAV until 10 November, 2024.
- This MOU grants no party the right to engage in any arrangement relating to RGIPT, except those directly linked to the implementation of this MOU during URJOTSAV 2024.
- The company is affiliated with URJOTSAV 2024, RGIPT, not RGIPT.
- The Company shall not utilize the name or logo of RGIPT in any promotions or certifications. The Company may, however, utilize URJOTSAV RGIPT's name and/or logo for lawful reasons.
- In the event of an unforeseeable or force majeure occurrence, URJOTSAV maintains the right to postpone, shift, or cancel the program.
- This Memorandum of Understanding will only be valid if it has been accepted, signed, and stamped by authorized representatives of both parties.
