1. Agreement:

- LWT Academy Commerce has agreed to participate in the NM Techfest under the mutually agreed deliverables mentioned under this MOU's annexure.
- Both the parties will comply with all the deliverables as mentioned in the MOU's annexure below

2. Terms & Conditions:

- a) Force Majeure: In the event, that either party is unable to perform its obligation under the terms of this agreement because of acts of God, strikes, equipment or transmission failure, damage or other causes reasonably beyond its control, such party shall not be liable for damages to the other for any damages resulting from such failure to perform otherwise from such causes.
- b) Confidentiality: The parties acknowledge that the terms of this agreement and the information exchanged will be regarded as confidential information. It shall not disclose any such information to any third parties.
- c) Each Party agrees to indemnify and hold harmless the other party against any risks, costs, losses, claims, charges, taxes, dues or other party may be subjected to as a consequence of the breach of terms of this MoU by the non-affected and/or wilful misconduct and negligence of non-affected parties.

- d) Each Party represents and warrants that It will comply with all applicable laws, rules and regulations It has obtained any and all permits, licenses and third-party consents or approvals necessary in connection with this MoU.
- e) In case of any dispute, the parties will try to settle it amicably before resorting to other legal remedies. Laws of the Republic of India govern this MoU, and the Courts at Mumbai shall have exclusive jurisdiction regarding all disputes/ differences arising hereof.
- f) NM Techfest does not guarantee sales and hence should not be held accountable for them.

3. Obligations of LWT Academy Ltd Commerce:

- a. Shall cooperate with Narsee Monjee College (Autonomous) and NM Techfest and not affect its reputation.
- b. If there is a conflict with SVKM Management Policy, NM Techfest shall terminate this MoU thereafter.
- c. Shall not hold NM Techfest responsible for branding materials provided by the sponsor after the event.

- e. Shall make sure that the confidential information is not disclosed to any third party.
