WHEN DO I FILE? Noon, Monday, December 1 - Noon, Friday, December 19

WHERE DO I FILE? Jackson County Board of Elections – 876 Skyland Dr. Sylva, NC 28779

WHAT ARE THE QUALIFICATIONS?

- Must be a registered voter of the county
- Must be at least 21 years old on Election Day
- Where there is a district, must also reside within that district.
- Sheriff Candidates must obtain a valid Felony Disclosure Statement from the NC Sheriffs' Training & Standards Division to file along with their notice of candidacy form. Before filing, candidates must complete several forms and a disclosure statement verifying that they have had no prior felony convictions or expungements. Find the forms and additional information at the Sheriffs' Training & Standards Division NCDOJ.

WHAT DO I NEED TO BRING?

- Valid NC driver's license or photo ID for notarization
- Payment for filing fee. Our office can only accept payment by check; other payment methods can be utilized at the Finance Office within the Jackson Co. Justice Center. Filing fees under \$50 can be made in cash.
- Any completed campaign finance documents.
- Sheriff Candidates must bring the Felony Disclosure Statement from the NC Sheriffs' Training & Standards Division.

All candidates are required to create a candidate committee. A candidate committee is required to complete organizational paperwork within 10 days of:

- 1. Receiving money or anything of value in support of the campaign; or
- 2. Spending money in support of the campaign; or
- 3. Giving consent for anyone else to receive or spend money for the purpose of bringing about an individual's nomination or election to office; or
- 4. Filing a notice of candidacy.
