**Secretary's Report (Billy Hatchell):** Feb 2026 tournament results/winners posted to TCSGA website and FB, and March 2026 tournament registration cards (Traces GC) were uploaded to the TCSGA website and Facebook page.

TCSGA website had 1411 views in the last 30 days and 310 views in the last 7 days. TCSGA performance 93%.

Champion Golfer of the Year: Feb tournament points have been inputted.

TCSGA member Byron Taylor submitted another Champion of the Golfer database to input and follow tournament points. The BOG all voted to continue to use the database that Steve Lyles produced. The BOG also decided that a monetary award to the Champion of the Golfer is not an option. The GOB believe that a trophy would be more meaningful along with the winner on a plaque. The trophies for Champion Golfer of the year will be decided on in the future.

What still needs to be discussed is the procedure for tiebreakers and needs to be decided on soon.
