



PRIVACY POLICY

Effective Date February 24th 2026

A. Information to the User

Users of the website are informed about KG SPORTS, LLC's policy regarding the processing and protection of personal data of users and clients.

KG SPORTS, LLC is responsible for the processing of the User's personal data and informs users that such data will be processed in accordance with applicable United States federal law and the laws of the State of California, including the California Consumer Privacy Act CCPA and the California Privacy Rights Act CPRA, where applicable.

Users are informed that they have the right to request access to their personal information, request correction of inaccurate information, request deletion of personal information, and exercise other rights granted under applicable law. The data subject is informed and, where applicable, consents to the communication and processing of their personal data under conditions of confidentiality and appropriate security safeguards, for the period necessary for the purpose for which they are collected, processed, and shared, and under the conditions indicated below.

B. Information on the Processing

In accordance with applicable data protection regulations in the United States and California, the user must receive timely and specific information from the person responsible for the processing and the uses and purposes thereof. For this reason, the following information is provided:

Purpose of the Processing

KG SPORTS, LLC processes the information provided by interested parties in order to:

Manage the registration of the registered minor in camps, tournaments, or related sports programs.

The data will be kept for a reasonable period necessary for business, insurance, and legal purposes following the participant's last registration or participation, unless the data subject has previously exercised their right to deletion where applicable.

Be able to contact users to provide requested information if they submit an inquiry through the website, either by email or by phone.

The data will be deleted once the query made is considered resolved, unless retention is required for legal or administrative purposes.

Send newsletters if the user has subscribed through a registration form or website form.

The data will be kept for the duration of the subscription to the newsletter, unless the user unsubscribes.

Carry out commercial communications related to programs, events, and services offered by KG SPORTS, LLC, if the user has consented to this at the time of registration.

The data will be kept for the duration of the consent or until the user opts out.

Send advertising or promotional information about sports brands sponsoring the event, depending on the options selected on the registration form.

The data will be kept for the duration of the consent or until the user opts out.

Collect and process medical or health related information about minor participants solely for participation eligibility, health, and safety purposes during camps and events. Such information is treated as sensitive personal information under California law and is used only as necessary to ensure participant wellbeing and compliance with safety requirements.

Period of Retention of Your Data

The personal data provided will be kept during the commercial relationship and for a reasonable period thereafter necessary to comply with legal obligations, insurance requirements, and business recordkeeping requirements, unless the data subject has previously exercised their rights under applicable law.

Legal Basis for the Processing

KG SPORTS, LLC is authorized to process your data:

Because it is necessary for the proper management of registration and operation of the camp or tournament.

In the case of responding to queries sent by the interested party, based on the consent provided when submitting the inquiry.

In the case of sending newsletters, based on the user's express consent when entering their data and accepting the privacy policy.

In the case of sending advertising related to KG SPORTS, LLC programs and services, based on express consent provided when filling out the registration form.

In the case of sending advertising from third party companies sponsoring the event, based on express consent provided when filling out the registration form.

Recipients of Transfers or Assignments

The data collected may be shared, where necessary, with service providers engaged by KG SPORTS, LLC for the proper management of programs and contractual obligations. These may include payment processors, insurance providers, technology providers, marketing service providers, and administrative support providers.

KG SPORTS, LLC only contracts with service providers that offer sufficient guarantees regarding the implementation and maintenance of appropriate technical and organizational measures in accordance with applicable law and that guarantee the protection of the rights of affected individuals.

Personal information will not be sold.

Data may also be disclosed if required by law, court order, or governmental authority.

Rights of Interested Parties

Any interested party has the right to obtain confirmation as to whether KG SPORTS, LLC is processing personal data concerning them.

Interested parties have the right to access their personal data, request correction of inaccurate data, and request deletion of their data when, among other reasons, the data are no longer necessary for the purposes for which they were collected, subject to legal limitations.

In certain circumstances, interested parties may request limitation of the processing of data and may object to certain processing activities as permitted by law.

To exercise these rights, the interested party may contact KG SPORTS, LLC through the email address or postal address indicated in the first section.

If a California resident believes their privacy rights have been violated, they may also submit a complaint to the California Attorney General's Office.

C. Security Measures

In accordance with applicable United States and California data protection regulations, KG SPORTS, LLC complies with its obligations regarding the processing of personal data under its responsibility. Personal data are processed lawfully, fairly, and transparently in relation to the interested party and are adequate, relevant, and limited to what is necessary.

KG SPORTS, LLC has implemented appropriate technical and organizational security measures designed to protect personal information against unauthorized access, disclosure, alteration, or destruction and to safeguard the rights and freedoms of users.
