## Boarding Service Agreement

1. **Vaccinations and Preventatives**

All dogs must be current on Rabies, DHLPP(Distemper, Hepatitis, Leptospirosis, Parainfluenza, Parvovirus), and Bordetella. **We cannot check dogs in without proof of vaccinations.** To ensure the comfort and safety of all our guests, dogs must be on routine flea and tick preventative prior to their stay. If a scheduled dose of preventative is due during their visit, please bring it along, and we will administer at no additional charge. Upon check-in, all pets are examined for fleas. Should fleas be detected, an appropriate fee for flea treatment will be applied based on the dog's weight. Dogs should also be free of worms. This measure ensures the well-being of all dogs. I understand that my pet will be treated for fleas/ticks, at my expense, if they are detected.

2. **Boarding Pricing:**

- Overnight (24 hours): \$35.00 per dog
- Multi-Dog Overnight (24 hours): \$20.00 per additional dog, *sharing kennel*.
- Partial Day (8 hours or less): \$25.00 per dog.
- Multi-Dog Partial Day (8 hours or less): \$15.00 per additional dog, *sharing kennel*.

3. **Forms of payment accepted:** Cash, check, Venmo. 3% fee applies to Venmo transactions. \$25 returned check fee.

4. **Additional Services**

We do not offer haircuts, nail trimming, or any other type of grooming. Seasonally, a hose bath (shampoo, condition, towel dry) is available. Great for dogs that are coming to adventure in the woods and swim!

-Hose bath and towel dry: \$10.00

-Anal gland expression: \$10.00

-Bath & gland expression: \$15.00

5. **Check In/Out**

**Confirmed reservations are required for boarding services at Lake Vibes Canine Boarding, LLC. Please call/text 660-723-9484, PM us on Facebook, or email lakevibescanineboarding@gmail.com to schedule check in/out day and time and/or tour of kennel/grounds.** Open check in/out times are limited so that we can spend day-light hours exercising the dogs in our care. We are happy to accommodate check in/check out, *by appointment*, 11AM-7PM.

**-Open Check In/Check Out: 8:00 AM-11:00 AM, 365 days/year:**

Check in AND check out anytime between 8 AM and 11 AM is considered "24 hours". Guests not checked out by 11 AM, on the scheduled check out day, will incur a partial day rate up to 8 hours, per dog. Guests not checked out by 7 PM, on the scheduled check out date, will incur an additional overnight rate, per dog.

Example: Drop your dog(s) off at 8AM and pick him/her up at 11AM the next day, is "24 hours".

**-Check In/Check Out ,by appointment, 11 AM-7 PM, 365 days/year:**

Checking in OR out by appointment is **24 hours from the time of check in**. Guests not checked out within 24 hours of their check in will incur a partial day rate (up to 8 hours), per dog. Guests not checked out by 7 PM, on their scheduled check out day, will incur an additional overnight rate, per dog.

6. **Extension/Early Departure**

I will be checking my dog(s) in with the intent to pick them up on their scheduled departure day. If I am unable to pick my pet up on their scheduled departure date I will notify Lake Vibes Canine Boarding LLC to request an extension. Regardless of reason, once checked in, I understand that I am responsible for payment of all days reserved, regardless of picking my pet up prior to their scheduled departure date.

7. **Cancellation Policy**

Please provide notice of cancellation 48 hours prior to the scheduled check-in day.

8. **Photo and Video Release**

I agree to allow Lake Vibes Canine Boarding, LLC to use my pet's name and any images or videos taken while he/she in Lakes Vibes Canine Boarding, LLC, in any format, for use, at any time, in any media, marketing, advertising, illustration, trade, or promotional materials.

9. **Personal Property**

I agree that Lake Vibes Canine Boarding LLC shall not be responsible or liable for any lost, stolen , or damaged personal property belonging to either my dog(s) or me, including GPS collars.

10. **Medical Concerns/Emergencies**

If, at any time during your pet's stay, a medical concern arises that does not require immediate attention, you will be contacted and advised of the situation, and we will follow your instructions. In the event of an emergency situation or injury that requires IMMEDIATE medical attention, we will make every attempt to contact you and your emergency contacts for instruction. If we are unable to reach you or your emergency contacts, we will proceed with transporting your pet to an appropriate facility to be seen by a licensed veterinarian for minimal life saving treatment. I understand that I am financially responsible for all related expenses should my pet require medical/emergency treatment during their stay, including transportation.

11. **Transportation**

If my pet is transported to or from Lake Vibes Canine Boarding, LLC by Lake Vibes Canine Boarding LLC, it's owners, employees, or agents I agree to hold Lake Vibes Canine Boarding, LLC, it's owners, employees, or agents harmless in the event of injury or accident during transportation.

12. **Feeding Instructions**

Dogs are fed at approximately 6AM and 5PM, daily. Please bring enough food for their stay, plus a few extra days. Please bring food in the original bag, or container w/lid labeled with the pet's name. If your dog runs out of food during their stay they will be fed Hunters Blend Dog Food at a rate of \$3.00/day.

### **Liability/Release Statement**

I represent that I am the owner and/or authorized guardian of my pet and I am fully authorized to enter into this agreement. I understand that Lakes Vibes Canine Boarding, LLC reserves the right to deny admittance to any dog for any reason, at any time. I represent that my dog(s) meet all of the following requirements: (1) is four months of age or older, (2) is current on his/her required vaccinations, (3) is on monthly flea and tick preventative and free of worms, (4) has been in good health for the last 30 days prior to check in, (5) my dog will enter and exit Lake Vines Canine Boarding, LLC on a leash.

I certify that the information provided in this form is accurate to the best of my knowledge, and I have not withheld any information regarding our pets' health or behavior that could endanger other pets or staff in the facility. I am aware that Lake Vibes Canine Boarding, LLC staff are not veterinarians and cannot diagnose, treat, or detect illnesses. I understand there are inherent risks to bringing my pet(s) to a boarding facility and that vaccines do not protect against all contagious diseases that may affect my pet. I agree that I am assuming all risk of illness,

disease, harm or otherwise to my pet by allowing my pet to participate in services and activities at Lake Vibes Canine Boarding, LLC. I agree to allow Lakes Vibes Canine Boarding, LLC to obtain veterinarian medical treatment for my pet, in its sole discretion it appears, that the pet is ill, injured, or exhibits any other behavior that would reasonably suggest that my pet requires medical treatment by a licensed veterinarian. I agree that I am fully responsible for the cost of any such medical treatment, including transportation.

I fully understand that if my pet is not picked up by myself or an authorized representative within 10 calendar days of their scheduled departure date, that my pet will be deemed “abandoned” in accordance with Missouri State Law RSMO 578.009. If after 10 days Lake Vibes Canine Boarding, LLC is unable to contact the owner, via proper notification, arrangements will be made to re-home the dog(s). I fully understand and agree that if I abandon my pet at Lake Vibes Canine Boarding, LLC I may be unable to retrieve my pet(s) and will have no recourse against Lake Vibes Canine Boarding, LLC. In addition, I understand that I will still be responsible for the unpaid charges incurred for my pets stay.

I agree with Lake Vibes Canine Boarding, LLC. will not be liable for any claims of injury, illness, damage, or death to my pet during its stay and that under no circumstances will Lake Vibes Canine Boarding, LLC be liable for consequential damages. I agree that I am responsible for any harm caused by my pet while in the care of Lake Vibes Canine Boarding, LLC. I shall indemnify Lake Vibes Canine Boarding, LLC against any claims made against it or for losses or damages suffered by Lake Vibes Canine Boarding as a result of my pet. I understand that I will be responsible for any and all costs incurred during this and any future boarding stays.

Each time I bring my pet into Lake Vibes Canine Boarding LLC, I am re-affirming the terms of this agreement and the truthfulness and accuracy of all the statements I have made in this agreement. Should any of this information change before a future boarding stay, I will notify Lake Vibes Canine Boarding, LLC.
