

500 members met in Indianapolis for the Great Sun Council and to celebrate the 100th anniversary of the Order.

There were over 170 tribes.

The largest tribe (No. 52) had 375 members.

Red Men took care of their members' families. Over 350 orphans of Red Men were supported with over \$8700 during a 12-month period.

#### Did you know?

When Red Men traveled, they used a handy telegraph shorthand. It was a cheaper way to communicate between tribes than costly long distance telephone calls or sending long telegraph messages. Members might apply to a local tribe for help. An example would be to know if (1) Charlie Jones was a member in good standing and (2) how much money might be given to him. In this case, you could simply send "Charlie Jones *Penanuh Amo*."

## The Back of a 1930 Membership Dues Receipt

This is the only legal receipt for dues and other charges and its use is required in all Tribes and Councils. It is a proper credential for visiting in all Reservations of the United States. Its use is limited to the date provided by law. The holder shall prove identity and good standing in the matter prescribed by the laws of the Order, and upon such proof, the Presiding Chief of the Branch visited is authorized to communicate the U. P. W. Payment of benefits or pecuniary aid is not authorized by this Dues Receipt.
