

# SUITABILITY, LOCATION, & TOPOGRAPHY FOR DEVELOPMENT OF PROJECT

- Located in a residential area.
- The trail will be incorporated into the natural landscape.
- The proposed trail will be constructed in a flatter area of the parcel where less site work and grading will be necessary to make the trail most accessible.

# STATE COMPREHENSIVE RECREATION PLAN OBJECTIVE: ADVOCACY & FUNDING

 The City of Hendersonville and the Friends of Indian Lake Peninsula (FOILP) have made great effort to address the State's goal of advocating for recreational activities and programs through funding and planning. Both have worked to expand and maintain desirable recreational facilities and programs for citizens of Hendersonville and surrounding areas. This has been demonstrated through the City's yearly dedication of funds to Parks & Recreation facilities and recent contribution to countywide master planning efforts. Utilization of Recreation Resources Division (RRD) funds will allow FOILP to double the impact of the funds raised to date to develop trails in the Batey Farm area.

The proposed 2020 Parks & Recreation Fund project will develop and improve recreational opportunities activities in Hendersonville.

# STATE COMPREHENSIVE RECREATION PLAN OBJECTIVE: RECREATION ONE-STOP

• The City of Hendersonville wishes to provide the community with access to information regarding their recreational facilities and programs. The City's website is a great resource for general information. However, if the City's parks and recreation Facebook page provides important information about events and happenings in the Hendersonville parks and recreation system. The FOILP website and Facebook page informs the public about fundraising efforts and developments in preservation in the area.

### STATE COMPREHENSIVE RECREATION PLAN OBJECTIVE: PUBLIC HEALTH

• The proposed trail development will add opportunities for exercise and outdoor recreation within Hendersonville's parks and recreation system. This will improve quality of life as well as encourage residents to enjoy the outdoors, exercise, and meditate. The facilities can be enjoyed by individuals, families, and groups.

# STATE COMPREHENSIVE RECREATION PLAN OBJECTIVE: CHILDREN IN NATURE

- All of the proposed project activities will encourage and enable the children of Hendersonville and surrounding areas to engage in outdoor exercise.
- The proposed trail will be ideal for nature walks and other events for local children's groups like Girl Scouts and Boy Scouts.

# STATE COMPREHENSIVE RECREATION PLAN OBJECTIVE: ENVIRONMENTAL EDUCATION

 The proposed trail construction provides a variety of outdoor educational opportunities for the citizens of Hendersonville. Environmental education events for children and families will be made possible at the site.

### STATE COMPREHENSIVE RECREATION PLAN OBJECTIVE: QUALITY GROWTH

• The City of Hendersonville has an understanding for the importance of Quality Growth in the development of new recreational activities. FOILP supports Quality Growth efforts. All of the proposed trail will complement, not interrupt, the valuable natural infrastructure of Middle Tennessee.

### STATE COMPREHENSIVE RECREATION PLAN OBJECTIVE: RURAL ECONOMIES

• The City of Hendersonville is a suburb of Nashville. Although the area has grown significantly in recent years, small businesses are still a critical component of the local economy. ### PROJECT DESIGN ELEMENTS TRAIL DEVELOPMENT

#### Use of Site

- Proposed trail will increase utility of the currently vacant parcel.
- As many trees as possible will remain to provide shade to trail users and preserve the natural beauty of the site.
- The paved surface and minimal grades will allow more citizens to utilize the trail regardless of disabilities.

### PROJECT DESIGN ELEMENTS FARMERS MARKET PAVILION

#### Access

 The trail will be open to citizens between sunrise and sunset, and longer during special events.

#### Ease of Maintenance

 Upon completion of development, FOILP will give the parcel to the City of Hendersonville who will maintain the site.







#### PROJECT LOCATION MAP




