### HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 3 MINUTES OF REGULAR BOARD MEETING December 17, 2020

# 1. Consider and take appropriate action on the request to approve the minutes of the November 19, 2020 Special Board Meeting.
