RENTAL FEES ARE CREDITED TOWARD PURCHASE OF A NEW INSTRUMENT.

- Rental fees are payable in **advance**. Rental is on a month to month basis. Monthly payments will not be pro-rated and fees are not refundable. Any time period less than a full month will be billed as a full month. Instruments are cleaned adjusted, sterilized, and in excellent playing condition when rented. The instrument remains the property of **MUSIC HUT** and is **not** for sale. The customer does not acquire any security in the lease instrument.
 - Continuous** rental accrues credit. This "RENTAL CREDIT" is your rental payment (minus the tax and \$ 3.00 for group 1 and \$6.00 for group 2 and 3), accumulating with each current, continuous rental payment, that can be applied to the manufacturers current suggested retail price, should you decide to purchase a new same type instrument (ie: flute for flute) that you are renting. Rental credit cannot be used for purchasing used/ return rental instruments, accessories, or non instrument items or services or repairs. New instruments may be purchased at any time during the contract. The purchase price of the new instrument must be of equal or greater value than the retail price of the instrument rented. Purchase must be made during the rental period or no later than 30 days after rental ends and instrument returned. When instrument is returned, RENTAL CREDIT is forfeited, and has no cash value, and can not be transferred to another person, or saved for future use.
 - Rental/Maintenance coverage is included in the rental fee and covers any adjustments and/or repair as long as they are not the result of damage, negligence or willful destruction and payments are current. This does not cover expendable accessories (reeds, sticks, strings, etc.). MUSIC HUT reserves the rights in determining misuse, neglect or damage. All repairs **must** be done by **MUSIC HUT**.
 - Payments are due on or before the due date, whether instrument is being used or not. Accounts are in default if not received by the due date, or if you fail to observe any other terms of this agreement. Renter authorizes MUSIC HUT to contact relative or friend listed on contract when MUSIC HUT is unable to contact customer.
 - \$25.00 fee for checks returned for any reason. Past due fee of \$3.00 a month on delinquent accounts.
 - Rental Instruments are the responsibility of the customer (parent or guardian) persons signing the contract, and said responsibility includes rental payments, reimbursement of any lost or stolen instruments or accessories, and payment for any damage that occurred during the rental, whether accidental, at home, or at school, by my child or a child at school, if due to negligence or willful destruction. Customer is responsible for any and all collection costs involved on delinquent accounts, including legal fees and court costs.
 - DO NOT JUST LEAVE THE INSTRUMENT AT SCHOOL.
 - Arrangements for return can be made by phone. Customer is liable if MUSIC HUT is not notified and instrument is missing.
 - The contract is not subject to bankruptcy as money collected is rent and the instrument is the property of MUSIC HUT.
 - The instrument may be returned, at any time, terminating this agreement, provided monthly payments are current, and all accessories included with the rental are returned, and instrument is not damaged. Upon return, any damage will be evaluated by MUSIC HUT REPAIR DEPT. and repair cost determined, along with any unpaid past due rental fees, and amount due will be charged to current credit card, and contract terminated. Any rental credit is then considered just rental for that instrument, and is not transferable or available for use in the future.
- The rental instrument is the property of MUSIC HUT and I agree it may be picked up if the terms of the contract are broken, or for non payment of rental fees, if in default over 15 days.
 Non receipt of billing does not exempt the customer from liability of scheduled payments or if a customer fails to notify MUSIC HUT of change of address, or if the instrument is not received by MUSIC HUT before the date due, or is just left at school without notifying MUSIC HUT of return.

Notice of right to cancel—You may cancel this transaction, without any penalty or obligation, within three business days from the date signed below. To cancel this transaction, Mail or deliver a signed and dated copy of this cancellation notice or any other written notice, or send a telegram to **MUSIC HUT**, 1120 Whitmore Rd., North Huntingdon, Pa., 15642 not later than midnight, of the third day following the initial date of this transaction.
